2. 登記送貨日期: 2021 年 6 月 2 日上午 7 時正至 2021 年 6 月 8 日下午 11 時 59 分, 逾期作廢。  
Registration period starts from 2 June 2021 7:00am to 8 June 2021 11:59pm. This redemption coupon will be expired afterwards.
